

# PHYSICAL, DENTAL, VISION EXAMINATIONS AND IMMUNIZATION REQUIREMENTS

<b>PARENTS: Proof of the following must be turned in <u>by October 15, 2022 or students will be excluded from school</u></b>

	<b><u>School physicals, along with proper immunizations should be submitted to the school nurse by October 15, 2022</u></b>						

Health examinations shall be reported on the forms that the Department of Public Health and the Illinois State Board of Education prescribe for statewide use.

**IMMUNIZATIONS**-All children shall present proof of having received required immunizations against communicable diseases *on or before October 15, 2022.*

A child is considered in compliance of the School Health Code if all immunizations are documented on an acceptable immunization record form.

Parents or legal guardians of any student entering Kindergarten, 6<sup>th</sup> or 9<sup>th</sup> grades who object to immunizations on **religious grounds** must submit the completed “Illinois Certificate of Religious Exemption” form by October 15, 2022, found at:

Any **medical objection** to an immunization must be documented by a physician and presented to the local school authority as well.

**DENTAL**-All children in Kindergarten 2<sup>nd</sup>, 6<sup>th</sup>, and 9<sup>th</sup> grades, must present proof of having been examined by a licensed dentist. Forms are available from your dentist or can be found at:

**VISION**-All Illinois children in Kindergarten or **upon first entering an Illinois school beyond kindergarten (i.e., grades 1-12) are required to have an eye examination by a licensed optometrist or ophthalmologist and submit proof of examination to the school.** Forms are available from your eye doctor or can be found at:
